HAULING AND STORAGE: 50% DEPOSIT REQUIRED All prices are L.O.A. (Length overall) and include hauling, blocking, and relaunch.
* Between The Bridges Marina will attempt to remove all exterior drain plugs but it is the vessel owner's responsibility to ensure that all plugs are removed after haul out. In the spring, please pick up discarded material from around your boat and place the refuse in one of the dumpsters. We will charge \$ 100.00 to clean up after you. Under no circumstances are you to tie boat covers to poppets supporting your boat.

SUB CONTRACTORS: No outside labor or independent contractors' work is allowed unless permission is obtained from the yard office. The Yard will require proof of liability insurance in the amount of \$5,000,000 and Workmen Compensation Insurance. Outside contractors must complete forms available in the office and sign in and out of the office daily. Permission from boat owner must be given to office in writing before any subcontractor is allowed in yard. Subcontractors must abide by Marina rules and manager's directives. Subcontractors must check with marina for rules and conditions before entering property.

Electric cords cannot be left plugged in unattended and will be disconnected by the yard.

NOTE: Reservation is considered confirmed only upon receipt of signed contract (all particulars completed) and accompanied by a non-refundable deposit totaling half of storage and shrink-wrap which is due no later than October 1, 2011. Marina reserves the right to assess a 10% surcharge for winter contracts received after October 15, 2011. Balance of storage and service is due when bill is rendered. A 1.5% finance charge will be added to all accounts 30 days past due. All work will be halted until the account is current. A 1% environmental surcharge will be added to all storage and service billing. There will be no refunds on deposits.

All deposits will be applied to open balances first.
